19/129 Apologies for absence

Apologies were received from Cllrs Sarah Lowman, Charles Barter (Vice Chair), Lizzie Guinn and Dorset Councillors Peter Wharf and Laura Miller.

19/130 To receive Declarations of Interest in accordance with S94 of the LGA1972 and consider any dispensations requested

Cllr Monro declared a non-pecuniary interest in the "Land at Shakes Hole" planning application. The Chair agreed that Cllr Monro could remain in the meeting for the discussion but that he would not participate in either the discussion or the vote.

19/131 Public Participation Time

A resident stated that he had contacted Dorset Council about the flooding issue around the junction of Yearlings' Drove and the road leading to Turnerspuddle. He reports that Highways came out quickly and cleared the grips in order to resolve the situation and asks that the Parish Council thank the Highways Team for a job well done.

RESOLVED that the Clerk contact Katie Black to establish the status of the application to install gates at Gulley Lane and to secure the assurances requested by the Parish Council as conditions of any grant of permission.

Distribution of grit, in line with the Parish Council's Snow Plan was agreed.

RESOLVED to comment online and in the next Parish Magazine, reminding the community that Graham Lightfoot is the Flood Warden and how he may be contacted.

19/136 Planning Applications

Proposal: Change of use of the land from agricultural to use for leisure purposes including archery, off road, buggy racing, 4x4 vehicle driving and blind driving (with related equipment and structures including poles, flagpoles, fences, vehicles, sheds, portaloos and carting van and the creation of earth bunds - (with variation of conditions 2 & 3 of reference APP/F1230/C/07/2056624 to allow activities to take place on four days per week (excluding Sundays) plus a variation of hours of operation to 8am - 18.30pm between 1st April - 30th September in any calendar year.

RESOLVED to OBJECT to the application on the same grounds as last time. The Clerk pointed out that the Parish Council's comments are not on the Dorset Council website, in future the Clerk will check that comments are being included on applications. **Action: Clerk**

19/137 Rights of Way, Highways and Roads

Drainage issues at Shop Hill/the Hollow

The drains have now been cleared by Highways and a more comprehensive drain clear has been promised. This must be maintained, and it was agreed that Cllr Lightfoot would monitor the condition of the drains and report to county when they need clearing.

Footway to link Briantspuddle and Affpuddle

Although initial discussions with landowners are encouraging, further development of the proposal is needed and more information concerning land ownership is to be gathered. It was agreed that no further action would be taken at this time but that the plans would be reviewed in six months or when new information is available.

The report was received and there were no comments.
