22/120 Apologies for absence

Apologies were received from Councillors Stuart Chorley and David Neudegg

22/123 Matters arising from the minutes of previous meetings

Cllr Graham Lightfoot reported that some residents noticed ground water flooding close to their properties which affected their ability to flush/empty toilets. These residents contacted Wessex Water.

Cllr Lizzie Guinn reported that Southover Farm movements were once again happening outside of agreed time periods and that the one-way system was not being observed. Movements included manure which was supposed to cease with the building of the Slurry Lagoon. The Slurry Lagoon Liaison Committee will meet and draft a letter to the planning authorities.

Cllr Damon Green updated that there was no progress yet on the plan for the woodworm reported previously in the Granary. However, this work would be scheduled.

Cllr Peter Wharf reported that the Battle Farm application has now gone to planning committee and that the earliest that the application would be reviewed would be the next meeting in March. Cllr Sue Jones confirmed that representation would be made from the Parish Council. Cllr Peter Wharf also suggested sending a letter stating the need for a site visit.

Cllr Emily Hall undertook to confirm the site(s) in Affpuddle where speedwatch can operate to the Speed Watch Group.
